

- Mr. & Ms. Union info in SGA Bylaws:
 - Section 5 Homecoming:
 - A) Any student nominated for the Mr. or Ms. Union ballot must be a Senior ~~by hours and by years~~ **have completed at least 90 credit hours**, have at least a cumulative ~~2.5 GPA~~ **3.0 GPA**, and not be on General Probation (refer to the Student Handbook).
 - B) ~~The Vice President of Administration shall provide a male and female nomination ballot to each organization immediately preceding the Senate session in which the Homecoming nominations are to occur.~~ **The Vice President of Administration shall provide a nomination form the Senate session prior to the nomination session. Any registered organization may submit a male and/or a female nominee for Mr. and Ms. Union by completing the nomination form.** The Vice President of Administration and Attorney General shall oversee the Mr. and Ms. Union nomination procedure **alongside the Homecoming Student Director and Assistant Homecoming Student Director.** ~~The final ballot for Mr. and Ms. Union shall not exceed ten (10) each. The nominees for Mr. and Ms. Union may submit a biography to be published by the Media Director.~~
 - C) ~~The Student Government Association shall prepare for homecoming nominations in accordance with the university's Homecoming Week.~~ **A list of the nominees will be compiled and then sent out to Senators, who will then vote for the top 10 candidates according to their organization's input.**
 - D) ~~The winners of Mr. and Ms. Union shall be publicly announced at a homecoming event.~~ **All nominees that meet the general qualifications must interview with a panel of Union representatives. This panel will select five men for the Mr. Union ballot and five women for the Ms. Union ballot. These nominees may then submit a biography to be published by the Media Director.**
 - E) ~~Any female student nominated for the Homecoming Court ballot must be within her respective nominating class and not be on General Probation (refer to the Student Handbook).~~ **The student body will have the opportunity to vote for the official title holders prior to the beginning of Homecoming Week.**
 - F) ~~Nominations are to be made at a closed Student Senate session (only Senators are allowed to vote) during the fall semester in conjunction with Mr. and Ms. Union nominations. The Class President or Chair shall preside over nomination proceedings. Ten (10) women shall be on the ballot.~~ **The winners of Mr. and Ms. Union shall be publicly announced at a Homecoming event.**
 - G) ~~One (1) representative will be elected from the Freshman, Sophomore, and Junior Classes. Four (4) representatives will be selected from the Senior Class, with the Senior who receives the most votes from the Student Body being named Homecoming Queen.~~
 - H) ~~The Homecoming Court and Homecoming Committee shall be notified of the results by the Vice President of Administration and/or SGA Advisor. The Homecoming Queen is not to be announced before the Coronation Ceremony.~~
